York. He completed his residency at the Edward S. Harkness Eye Institute at Columbia Presbyterian Medical Center and his research fellowship, in cornea and external eye diseases, at the University of Iowa with Dr. Jay Krachmer.



DAVID C. RITTERBAND, M.D.

is a Professor of Ophthalmology at the Icahn School of Medicine at Mount Sinai and is currently System Director of Refractive Surgery at the

Mount Sinai Health System. He is also Director of the Laser Vision Correction Center and Surgeon Director at the New York Eye and Ear Infirmary of Mount Sinai. Dr. Ritterband received his undergraduate degree from Duke University and his doctorate from New York Medical College where he completed his residency training in ophthalmology. He completed his Corneal and External Disease fellowship at The Eye and Ear Institute of the University of Pittsburgh's School of Medicine. Dr. Ritterband has published more than 65 peer-reviewed manuscripts; several book chapters, and more than 150 research abstracts.

Police Detective Celebrates 10th Anniversary of Receiving the Beautiful Gift of Sight

DETECTIVE ANITA MOORE started her career with the New York City Police Department in 2005 as a police officer assigned to the 23rd Precinct that serves the neighborhood of Manhattan north of 96th Street known as East Harlem or El Barrio. Through the years, she moved into different units, worked on task forces and in other precincts. In 2011, she was a plainclothes police officer working in an anti-crime unit when she noticed that her eyesight was lacking.

She went for eye exams and received glasses, but became concerned that even when wearing glasses, she couldn't see clearly. According to Anita, "I was working with my partner and couldn't read license plates or street signs." That was when she was sent to a specialist and learned that she suffered from an eye disease called keratoconus. A congenital and progressive eye disease, keratoconus can cause the cornea, the clear, outer covering of the eye, to become increasingly cone-shaped, until blindness occurs. It is often treated with hard contact lenses. Sometimes the cornea becomes so misshapen that a contact lens cannot be worn, but eyesight can be restored with a cornea transplant.

That is what happened to Anita. Her eyesight became progressively worse. She was wearing the special hard contact lenses but they didn't help. She recalled the moment she realized another solution was necessary. "I was on the job at night and chasing a suspect, when we collided and I fell. My contact lens popped out and I could hardly see!"

Anita was very concerned about her future as a police officer and for her life in general. "I was used to being very independent, loving my job, and loving to travel. And now I was

faced with the fear that I wouldn't be able to do any of those things. I needed to see to use a computer at work and to drive. I was worried about what my life would become."

Luckily for the Police Officer, on July 21, 2011, six months after being diagnosed with keratoconus, she received a sight-saving cornea transplant in her left eye with donor eye tissue provided by The Eye-Bank for Sight Restoration. Following her brief recovery, she was able to go back to work and soon thereafter was promoted to Detective, a position she holds today in the Special Victims Division, Child Abuse Squad in the Bronx.

Her transplant story doesn't really end there, however. Unfortunately, Anita's father, a Vietnam veteran, was seriously ill with liver disease most likely caused by a blood transfusion received when being treated for an injury. He had been on the waiting list for a liver transplant for more than 8 years, when it was determined that Anita could save his life by being a living liver donor to her father.

In little more than 6 months after her own sight-saving cornea transplant, Anita donated a portion of her liver to her father in a successful liver transplant procedure. Father and daughter are both healthy today. Detective Moore just celebrated the 10th anniversary of her sight-restoring cornea transplant by traveling to Ghana. And she and her Dad will celebrate what they refer to as their 10th "Liver-versary" in February 2022.

Detective Moore feels extremely grateful to her donor and her donor's family for her restored eyesight. "Thanks to my donor, I have in many ways been re-born. I am truly sorry for my donor family's loss, but want them to know how blessed I feel for the gift of sight from their loved one that I carry with me."

He is deeply grateful to the eye donors and their families for giving the beautiful gift of sight to them. "It has made a world of difference in all of our lives," says Holcomb. "It's important for me to encourage others to consider donation as a priceless legacy that lives on in others."

President's Report 2020



Before I report on The Eye-Bank's activities as they relate to the accompanying financials for the year 2020, I wish to acknowledge the steadfastness of the organization and its staff who continued to perform their roles through the unprecedented challenges of a public health crisis with diligence and dedication.

I also wish to pay tribute in memory of my predecessor, former Eye-Bank President James Fabian, who passed away in August 2020, after having so expertly served the organization and its mission of sight restoration for more than 18 years. I was very fortunate to serve as Vice President during his tenure and benefitted greatly from his knowledge and leadership, which I intend to uphold on behalf of The Eye-Bank.

Not surprisingly, the COVID-19 pandemic and the resulting restrictions on elective surgeries in The Eye-Bank's service area from March 17 to July 8, 2020 had an impact on the recovery and distribution of eye donor tissue. As a result, The Eye-Bank's Ocular Laboratory recovered a total of 977 eye/cornea donations in 2020 and provided tissue for a total of 1038 cornea transplants. Of those transplants, 563 cases were endothelial keratoplasty (EK) procedures and 97 percent (97%) of the tissue provided for those EK procedures was prepared by The Eye-Bank's laboratory technicians, which was an increase of four percent (4%) over the previous year's figure of tissue prepared by Eye-Bank technicians.

While the functioning of The Eye-Bank's Ocular Laboratory was maintained at all times, the limited need for donor tissue for several weeks mandated technicians to work on a rotational basis and The Eye-Bank's administrative staff worked from home and met via video conferencing to keep projects moving forward.

Plans were in place to celebrate The Eye-Bank's 75th Anniversary as the world' first eye bank, and many of those plans still came to fruition, albeit in different formats and venues, like people's homes via video conferencing.

One of our first adaptations to the COVID-19 pandemic was to alter our multi-media advertising campaign to urge New Yorkers to help flatten the curve by wearing masks and staying socially distant. And while continuing to remind the community to enroll in New York State's Donate Life Registry, the images included individuals wearing face coverings when they were outside their home.

Our Hospital and Community Liaisons were instrumental throughout the year in providing much-needed thank-you notes and gestures of appreciation to our service area's frontline workers in healthcare. Unable to visit in-person, The Eye-Bank's liaisons sent electronic signs of support and even participated in caravans driving by facilities with signs of encouragement for the overburdened hospital staffs.

In June, The Eye-Bank was well represented at the Eye Bank Association of America's (EBAA) annual meeting which was held via video conference over the course of several days. The Eye-Bank's Communications Director Noël Mick began her two-year term as Chair of the Association at the meeting which was attended by more than 1,000 eye banking participants from their remote locations. Also playing a key role was The Eye-Bank's Medical Director, Michelle Rhee, M.D. who moderated the annual Scientific Symposium and the Medical Directors Symposium. Another position in the EBAA was assumed by The Eye-Bank's Executive Director Patricia Dahl who was named Co-Editor-in-Chief of the International Journal of Eye Banking (IJEB) published by the EBAA as the only peer-reviewed publication devoted exclusively to eye banking.

During the fall, The Eye-Bank persevered with plans to celebrate our 75th Anniversary with the necessary accommodations for social distancing. On October 1, The Eye-Bank hosted its first-ever virtual Fall Benefit called *Sight-Seeing* with Emmy Award-winning travel expert Samantha Brown who guided attendees in an online tour of Austria. The evening included a wine tasting and a guided preparation of *Jagerschnitzel* and raised more than \$46,000 in support of Eye-Bank programs.

Also in October, The Eye-Bank co-hosted with the Venice Eye Bank Foundation, *Foresight 2020*, an international virtual scientific workshop. It was joined by 140 attendees from around the world to hear the panel of basic science and clinical researchers share their knowledge and perspectives about the potential for new treatments of corneal and retinal diseases.

And in November, The Eye-Bank hosted a very special virtual event marking its 75th Anniversary called *Celebrating You!* to honor eye donors and highlight cornea transplant recipients. The afternoon event featured video testimonials from donor family members; a special video greeting from award-winning actor Mandy Patinkin, who is a cornea recipient himself and the premier showing of The Eye-Bank's 75th Anniversary video chronicling our history from its founding in 1944 to our innovative work today.

As anniversary years go, it was turbulent and unexpected changes had to be made. But The Eye-Bank continued to carry out its mission of restoring sight, providing safe, quality ocular tissue for sight-saving procedures and honoring our generous eye donors and their families for giving the beautiful gift of sight.





CAPITAL TRANSACTIONS

The Eye-Bank, in association with outside, independent counsel, has its investment portfolio under continuous review. The review's purpose is to improve dividend and interest income with securities, which, in the carefully considered opinions of all concerned, are of sound value. With these objectives in mind, changes in holdings are made from time to time.

the Catholic Health EPIC software team for their dedication in providing credentials to The Eye-Bank recovery technicians, enabling them to view the electronic medical records (EMR) of potential donors prior to completing the eye donation recovery procedure. This essential step in the screening process ensures that donor eye tissue is safe and suitable for transplant or research.

This spring, the EPIC team expanded Eye-Bank technicians' onsite EMR access to include the ability to view records remotely from The Eye-Bank office before traveling to perform a recovery. The transition to remote access is a major process improvement in The Eye-Bank's ability to serve a group of five hospitals; Good Samaritan, St. Catherine of Siena, St. Charles, St. Francis and St. Joseph, all located throughout Nassau and Suffolk counties. By partnering with The Eye-Bank in a more efficient process, the Catholic Health EPIC team helps Eye-Bank technicians to recover more eye donations which ultimately helps more New Yorkers receive the beautiful gift of sight.

In addition to granting remote EMR access, members of the EPIC team accommodated Eye-Bank staffing needs by offering frequent and conveniently timed training classes. And we are grateful for how responsive and positive the Catholic Health staff have been in collaborating with The Eye-Bank to put systems in place to enhance our ability to help others to see again.

FROM APRIL 26-30, THE EYE-BANK JOINED **OTHER MEMBER ORGANIZATIONS** of Donate

Life New York State (DLNYS)—a statewide association of eye, organ and tissue recovery agencies—to conduct appointments over Zoom with state lawmakers and their staff. The meetings took place over the course of a week as opposed to conducting in-person meetings all in one day.

Eye-Bank staff members and volunteers met virtually with assembly members and state senators, educating them about our legislative priorities and allowing our donor families and cornea transplant recipients to share their personal donation stories.

We are pleased to report that our main legislative priority, the "Doorways to Donation Act of 2021," passed both houses of the state legislature. The bill creates additional

opportunities for New Yorkers to register as organ and tissue donors by adding the donor designation question to electronically processed NYS tax filings, applications and renewals for student aid and loan programs through the NYS Higher Education Services Corporation and applications for other social services. It is estimated that providing these additional portals will present more than 13 million New Yorkers with an opportunity to enroll in the registry. In addition, the Organ Transport Vehicle Act, which designates a vehicle transporting organs for transplants as an emergency vehicle and authorizes it to use lights and sirens, is also awaiting the Governor's signature.

The Eye-Bank thanks our volunteers who joined us virtually and whose dedication to our mission made these advocacy efforts successful.

The Eye-Bank's RPE Project Provides Cells for Research

THE EYE-BANK is currently supplying a number of researchers with adult human retinal pigment epithelial cells (ah-RPE) that have been isolated from donor eye tissue and cultured into high quality RPE monolayers in vitro. The Eye-Bank's RPE cell lines are especially valuable to ophthalmic researchers because they are primary cells cultured directly from donor tissue that can more accurately maintain the native physiology of in vivo RPE cells than other currently available stem cell-derivative RPE lines. RPE cells are essential to the study of retinal diseases and for the purpose of finding potential cures and treatments of diseases such as macular degeneration.

According to Brian McArdle, research supervisor at The Eye-Bank, it required extensive effort to establish the necessary processes to cultivate ah-RPE cells in The Eye-Bank's Ocular Laboratory, and it is

exciting to see the contribution our cell lines can make to innovative retina research. The Eye-Bank is able to supply vials of over 500,000 frozen cells to scientists who want to study retinal diseases using the highest quality of cells available

In the past several months, The Eye-Bank's RPE project has supplied cells to scientists conducting retinal research at The University of Michigan Kellogg Eye Center, Florida International University and The Veneto Eye Bank Foundation in Italy.

According to the National Eye Institute (NEI) macular degeneration is the leading cause of central vision loss in people over age 50. In addition to helping to restore sight by providing donor tissue for upwards of a thousand sight-saving cornea transplants each year, The Eye-Bank's RPE project can contribute to valuable research into diseases of the retina such as macular degeneration.
