## Eye-Bank Director Receives 2025 Leonard Heise Award

**EYE-BANK STAFF TRAVELED** to sunny San Diego, CA to attend the Eye Bank Association of America's (EBAA) 2025 Annual Meeting from June 25-28. This year's meeting was especially meaningful, as two leaders from our organization, both The Eye-Bank's former and current Communications Directors, received awards for their dedication to the EBAA's mission.

Former Communications Director Noël Mick Moschetta, who retired from The Eye-Bank in March of this year after 34 years of service to the organization, received the Leonard Heise Award, the highest non-medical distinction presented each year to a member of the eye banking community in recognition of their outstanding devotion to the EBAA's development and for exemplifying the precepts of Leonard Heise, one of the EBAA's founders. Throughout her impressive career, Ms. Mick Moschetta led many successful public and professional education initiatives for The Eye-Bank, including several multi-media advertising campaigns that elevated the cause of eye donation among New Yorkers. Her dedication to The Eye-Bank's mission has made a difference in the lives of countless individuals: corneal transplant recipients, donor family members, community members and professional colleagues alike.

EBAA President and CEO Kevin Corcoran echoed this sentiment in his remarks about Ms. Mick Moschetta's significant contributions to the field of eye banking at the national level. "Noël has dedicated herself to the restoration of sight," he said. "Her 12 years on the EBAA Board of Directors, including her time as Chair during the COVID-19 pandemic, and service on EBAA committees...are just a small part of her greater service to eye banking."

## **Medical Advisory Board Elects New Chair, New Members**

**THE EYE-BANK'S MEDICAL ADVISORY BOARD ELECTED** Joann J. Kang, M.D. to the position of Chair and welcomed Timothy A. Blenkinsop, Ph.D., Christine A. Curcio, Ph.D. and Gabriel M. Rand, M.D. as new members to the Board at their May 21<sup>st</sup> meeting. Dr. Kang will continue to serve as Associate Medical Director and replaces Himani Goyal, M.D. whose term as Chair has ended. The Board welcomed back returning member Gerald W. Zaidman, M.D. Members of the Medical Advisory Board consult on matters related to the Ocular Laboratory and Ocular Tissue Research Program in coordination with The Eye-Bank's Medical Director Michelle K. Rhee, M.D. Members may serve two consecutive three-year terms, after which they must rotate off the Board for a minimum of one year.

**CHAIR JOANN J. KANG, M.D.** is Director of Cornea and Refractive Surgery and an Associate Professor of Ophthalmology at Montefiore Medical Center/ Albert Einstein College of Medicine. She earned her medical degree from Columbia University's College of Physicians and Surgeons and her B.S. in Human Biology from Cornell University. Dr. Kang completed an internship at Maimonides Medical Center in Brooklyn and her residency training at the University of Illinois in Chicago. Later, she

completed a fellowship in cornea and external diseases at New York Eye and Ear Infirmary. Dr. Kang currently serves as a member on the Scientific Committee of the Eye Bank Association of America.



Timothy A. Blenkinsop, Ph.D.

TIMOTHY A. BLENKINSOP, PH.D. is Principal Investigator and Assistant Professor in the Departments of Cell, Development and Regenerative Biology and Ophthalmology at the Icahn School of Medicine at Mount Sinai. He is also a member of the Black Family Stem Cell Institute. His laboratory focuses on retinal pigment epithelium (RPE) and RPE-related diseases, including efforts to develop transplantation methods for introducing healthy human RPE cells to patients with degenerative eye conditions. Dr. Blenkinsop earned his Ph.D. in

Neuroscience and Biophysics at NYU Medical Center and later completed his postdoctoral fellowship at the Neural Stem Cell Institute.



Christine A. Curcio, Ph.D.

christine A. curcio, Ph.D. is Professor Emerita in the University of Alabama at Birmingham Heersink School of Medicine's Ophthalmology and Vision Sciences Department. Dr. Curcio has made seminal contributions to the anatomic and molecular pathobiology of age-related macular degeneration (AMD). She holds a Ph.D. in Neurobiology and Anatomy from the University of Rochester. She completed postdoctoral training in compensatory mechanisms in the aging brain at

Boston University and served as a Senior Fellow in the Departments of Biological Structure and Ophthalmology at the University of Washington.



Gabriel M. Rand, M.D.

GABRIEL M. RAND, M.D. is Assistant Professor of Ophthalmology at Columbia University Irving Medical Center and a board-certified cornea specialist. A graduate of the School of Engineering at Cornell University, Dr. Rand earned his medical degree from Albert Einstein College of Medicine, where he also completed his ophthalmology residency. During his residency, Dr. Rand was awarded the Ronald M. Burde Award for Excellence in Research for his

work on advanced statistical methods using eye bank data. He then completed a fellowship in cornea, anterior segment and refractive surgery at Columbia University Irving Medical Center.



Corald W. Zaidman, M.D.

GERALD W. ZAIDMAN, M.D. is Professor of Clinical Ophthalmology, Director of the Cornea Service and Vice-Chairman and Director of the Department of Ophthalmology at New York Medical College at Westchester Medical Center. A graduate of Queens College of the City University of New York, Dr. Zaidman earned his medical degree from the Albert Einstein College of Medicine. He completed his ophthalmology residency training at Beth Abraham Hospital and

Lenox Hill Hospital and his research fellowship in corneal and external disease at the Eye and Ear Hospital in Pittsburgh.

As of May 2025, Drs. Jessica B. Ciralsky, Robert C. Cykiert, Himani Goyal and Laurence T.D. Sperber have rotated off the Medical Advisory Board. The Eye-Bank thanks them for their expert contributions and dedicated service in support of our mission.

## **Elementary School Teacher and Father Gives the Gift of Sight**

**DAVID WIBBEN** had a joyful energy. A long-time resident of Kings Park, NY, Dave, as his friends called him, always made people feel welcome and appreciated. According to his wife, Nancy, "Even if you just met Dave, you felt like his best friend." Dave loved being a father. When they were still young and living at home, he would exclaim the names of his four children, greeting them with exuberance each time they walked through the door.

It was important to Dave that all children felt stable and supported. When the child of a family friend began to struggle with vision loss, Dave wanted to do something to help. He decided to become an eye donor so that, one day, he might be able to restore someone's sight.

A strong desire to help others also inspired Dave's choice of profession. For 35 years, he worked as a Physical Education teacher and coach at Walnut Street Elementary School in Uniondale, NY. He always left for work early to spend time with the students who attended the school's breakfast program.

When he passed away tragically in early 2020, Nancy and their children, now adults, were contacted by a donor coordinator and, remembering Dave's wishes to be an eye donor, the family wholeheartedly supported his choice. "It was very important to him to be a donor," Nancy said. The family took pride in donating Dave's corneas and soon received a letter from The Eye-Bank for Sight Restoration informing them that two individuals had received the gift of sight thanks to his generous donation.

Now, five years later, the Wibben Family's Long Island home is filled with thriving houseplants and light that glints from the frames of the many pictures of Dave that smile from the walls. Nancy

thinks of Dave each time she sees the white butterfly that hovers around the pool in their backyard where he loved to swim and spend time with friends and family. Nancy reflects on Dave's donation often and finds comfort in the knowledge that, even in death, he continued to change people's lives for the better.

"When I think of the recipients of Dave's corneas," she said, "I know they are seeing through the eyes of someone who loved others."

Kismeilyn Alcantara

A graduate of Valley Stream North High School, Kismeilyn is a rising sophomore at Nassau Community College where she is pursuing a degree in marketing and business administration. As part of her project's outreach efforts qualifying her for the Young Ambassador Scholarship, Kismeilyn conducted multiple tabling events at Nassau Community College, raising awareness about eye donation as well as helping faculty and students enroll in the New York State Donate

Life Registry. In addition, she created an informational brochure and presentation that answered many of the most frequent questions about eye donation. The Young Ambassador Scholarship was established by Eye-Bank Board Member Andrea Nordquist and named in memory of her son, Christopher, who became an eye donor when he died suddenly at the age of two.



Jonah Keller

Jonah will be entering his first year at University of Pennsylvania's Perelman School of Medicine in August 2025. He is a graduate of Cornell University's College of Arts and Sciences, where he earned his B.S. in Biological Sciences. In his research proposal that qualified him for the STEM Scholarship, he proposed a methodology exploring how artificial intelligence might be used to maximize the use of available donor corneal tissue by predicting optimal corneal transplant outcomes, thus enhancing

donor-recipient matching. The STEM Scholarship was established in memory of The Eye-Bank's former President James Fabian who served on the Board for a total of 18 years.

## **President's Report 2024**



The following report highlights The Eye-Bank's activities throughout 2024 as it relates to the accompanying financial information for the same period.

In 2024, The Eye-Bank's Ocular Laboratory recovered approximately 1,300 eye/cornea donations and provided ~1,200 corneas for transplants. Of those transplants, 50 percent were

performed as pre-cut and prepared tissue for endothelial keratoplasty (EK) including ~150 EK tissues pre-loaded for surgeons, representing a 36 percent increase over pre-cut and pre-loaded tissues in 2023. All EK tissue provided was prepared by The Eye-Bank's laboratory technicians.

In addition to tissue provided for transplants, The Eye-Bank, through its ongoing Ocular Tissue Research Program, continued to distribute vials of adult human primary retina pigment epithelial (ah-RPE) cells to multiple retina research studies in the United States (each vial contained 500,000 cultured cells). Just as The Eye-Bank provides custom-prepared corneas for transplant surgeons, we have begun to provide custom-prepared tissues to meet the needs of researchers. We distributed ~270 units of research tissue in 2024 comprising corneas, shells, lens, conjunctiva, retina and whole eyes. All tissues were used for human eye disease research.

In 2024, The Eye-Bank continued the previous year's multi-media advertising campaign with the encouraging message that, "Everyday New Yorkers Can Become Heroes" by enrolling in the New York State Donate Life Registry when they visit the Department of Motor Vehicles. The English- and Spanish-language ads ran in digital, radio, print and social media formats.

The Eye-Bank hosted two successful fundraising events in 2024. The Spring Benefit, themed as an "Outta Sight" Disco Night, was held on May 16 at the Bohemian Benevolent and Literary Association on Manhattan's Upper East Side. The evening of lively dancing and festive

'70s-themed costumes raised more than \$104,000 for The Eye-Bank's public and professional education programs. On November 15, the fall event was hosted for the first time by The Eye-Bank's Leadership Council. Held at Midtown Manhattan's Electric Shuffle, a venue outfitted with shuffle board tables for guests to enjoy, the event's approximately 150 guests enjoyed an "electric" atmosphere while raising more than \$68,000 to advance The Eye-Bank's mission.

I had the pleasure of attending the Eye Bank Association of America's (EBAA) Annual Meeting in Kansas City, MO from June 5-8.

At the House of Delegates meeting on June 7, The Eye-Bank's Medical Director Michelle K. Rhee, M.D. was elected to the EBAA's Board of Directors as a member-at-large and Eye-Bank Communications Director Noël Mick Moschetta completed her two-year term as Immediate Past Chair of the EBAA, rotating off the Board of Directors after six years of service.

In November, our annual Thanksgiving Card featured the artwork of Young Ambassador six-year-old Colin Kim whose sight was restored thanks to corneal tissue provided by The Eye-Bank. Our November Eye Donation Month campaign featured pediatric corneal transplant recipient one-year-old Greyson Moonassar.

Each year, The Eye-Bank for Sight Restoration is able to help restore sight to New Yorkers of all ages thanks to the selfless generosity of donors and their families. It is because of them that we are able to fulfill our mission of sight restoration, a mission that improves the lives of countless individuals. On behalf of our corneal transplant recipients and those who may benefit from future advancements, we express our gratitude for giving the beautiful gift of sight.





Since January 1978, in order to meet day-to-day expenses, The Eye-Bank for Sight Restoration, Inc., like other eye banks throughout the country, has assessed a fee for the processing of corneas.

The Eye-Bank has been able to build up a financial reserve thanks to the receipts from legacies. However, legacy income is largely unpredictable. 

### In Memoriam: David Paton, M.D.

**THE EYE-BANK MOURNS THE LOSS OF DAVID PATON, M.D.,** who passed away on April 3, 2025, at the age of 94. The son of R. Townley Paton, M.D., The Eye-Bank for Sight Restoration's founder, Dr. Paton was an innovative and prolific ophthalmologist as well as a strong supporter and advocate of The Eye-Bank throughout his lifetime. He contributed to the organization in a variety of ways, serving on the Medical Advisory Board from 1987-1992 and on the Board of Directors from 1995-2003. Dr. Paton remained an honorary member of The Eye-Bank's Board of Directors until 2024.

At age 41, Dr. Paton was named chairman of the Department of Ophthalmology at the Bayor College of Medicine in Houston, TX, where he was instrumental in founding the Cullen Eye Institute. He was a strong advocate of healthcare access and equity and brought eye care services to underserved populations using a mobile eye clinic. Dr. Paton later expanded on this concept when he founded Project Orbis, which transformed a DC-8 aircraft into a flying eye hospital that provided both patient care and professional training abroad.

Dr. Paton's son, Townley, described his father's life and legacy as "[living] on in the millions of lives transformed by his vision and dedication to restoring sight across the globe."
